There will be a \$25 Fee for each change, including changing or withdrawal from a class, made after registration is taken due to administrative costs.

SWIM ABILITY TESTING: Call for an appointment. Swim caps required for all children whose hair is below ears. Please do not change children on pool deck.

LESSONS: No class July 3. All classes are 1/2 hour except Competitive Clinic

SPECTATOR DAYS: For Mon.-Thurs. classes spectator days will be June 29th - July 2nd; for Fri. classes it will be July 10th.

EVALUATION WEEK: August 17-21. Swimmers will be tested to determine degree of achievement. No child fails; they are merely delayed until able to master all required skills.

MAKE-UPS: No make-ups in the summer. Friday fee is prorated.
